Proposed Site: The coal blocks is located in the Hemgiri Tehsil of district Sundargarh in the state of Odisha. Total Land requirement of coal block area is approx. 1308 ha.

Applicant: The Applicant, a corporate entity duly incorporated under the relevant laws, may be a single entity or a multiple entity through formation of consortium. The applicant must have the experience of executing any one of the following assignment (at least one assignment during last ten years) for coal/ lignite /any other minerals

- i. Environment clearance (having leased area more than 150 ha) or;
- ii. Forest Clearance (having forest area more than 40 ha) or;
- iii. Environment Clearance and Forest clearance

The agency responsible for conducting EIA/EMP for Environment Clearance must be accredited /provisional accredited with NABET/QCI under mining of minerals for Category “A” Projects.
