DETAILED TECHNCIAL SPECIFICATIONS

1. Scope of Works :

The scope of work includes following requirements:

- 1. Leasing of 01 nos of New Maruti Suzuki Ciaz top end model petrol car (Alpha A/T Petrol) or equivalent petrol car on Lease for a period of 4 years and 80000 KMs.
- 2. Fleet Management of above Cars (i.e. maintenance of above car(s) during the lease period).
- 3. The fuel for running of the car and Driver would be provided by PFCCL.

Lease-Financing of Cars means the agency shall be paid a monthly lease rent by PFCCL for the 4 calendar years towards the car provided by them on 24 hrs. basis throughout the lease period of 4 years (i.e. 24x7x365x4) and at the end of 4 years option should be available to PFCCL user to purchase the vehicle at Market Residual Value (which will be assessed by any reputed agencies)

Fleet Management of Cars means that the above car(s) will be well-maintained by the agency during the entire lease period of 4 years considering 80,000 km. running and it would be the responsibility of Fleet Management Company to arrange time to time service as well as repair of the car in case of break-down including towing of the car. In case the car could not be delivered duly repaired/serviced by the close of the day, an alternative arrangement will have to be made of the same status car without any extra charges. However, it is made clear the alternate arrangement of the car of similar status is to be provided till such time the car remains off road on any account. The alternate car will be provided from the next day without fail upto 7 days or leased car becomes on road whichever is earlier. The pick-up and drop facility for service of car should also be available without any extra charges. If the firm fails to provide the same status car, then PFCCL will arrange the same on the cost of the contractor. As the vehicle needs to be got repaired by the agency in case of accident also, it will be the responsibility of the Fleet Management Agency to provide insurance cover for the vehicle from day one

i.e. from the time it is taken out from showroom. (i.e. insurance cover for 4 years).

The above is the brief of the requirements of PFCCL Ltd. towards **Leasing and Fleet Management for the cars** being taken on lease.

The contract agreement for providing of cars on lease will be executed between the awardee agency and PFCCL. The terms & conditions incorporated therein shall be binding on the agency and valid for a period of 4 (four) years. Bidders are requested to quote their prices accordingly in the enclosed Financial Bid.

2. Lease Period

The cars shall be taken on lease for a period of 4 years. However, in the event of any unforeseen circumstances, PFCCL is at liberty to terminate the lease before 4 (four) years for which bidder should specify the charges for termination of lease prior to its completion in their commercial terms and conditions

3. Nos. of Vehicles

The likely no. of vehicles required is one nos. of New Maruti Suzuki Ciaz top end model (Alpha A/T Petrol) or equivalent car on Lease. However PFCCL reserves the right to increase/ decrease the quantity of Cars at the time of placing the PO.

4. <u>Delivery:</u>

Within 15 days from the date of Purchase order.

5.. Payment Terms & Conditions

The Monthly Lease Rent/ Fleet Management Charges shall be paid on monthly basis or as mutually agreed. In case of any major fault or in the event of accident and no alternate vehicle is provided, no payment for that period will be eligible.

6. Validity :

The quotation shall be **valid for a period of 01 (One) Month from** the date of opening of the bids.

7. PFCCL reserves the right to reject any or all bids without assigning any reason.
